## ZERO TO THREE Certified Trainer: *The Growing Brain* **Certification Criteria and Application Overview**



There are two stages of ZERO TO THREE Trainer Certifications: Stage 1. Provisional Trainer; and Stage 2. Certified Trainer. ZERO TO THREE digital Membership is included in both stages of certification.
