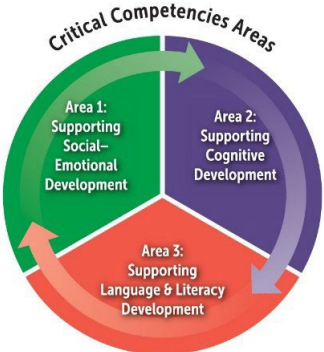


# ZERO TO THREE Certified Trainer: *Critical Competencies* Certification Criteria and Application Overview

There are two stages of ZERO TO THREE Trainer Certifications: Stage 1. Provisional Trainer; and Stage 2. Certified Trainer. ZERO TO THREE digital Membership is included in both stages of certification. This overview summarizes the ZERO TO THREE Certified Trainer: *Critical Competencies* timeframe, criteria, and evidence options by certification stage. Stage 1. PROVISIONAL TRAINER		Timeframe: valid for 1 year; candidates document meeting full Certification criteria within this provisional year
<b>Step 1: You must have an active ZERO TO THREE profile.</b> Create or confirm your learner profile on <a href="#">ZERO TO THREE   Learn</a> .		
<b>Step 2: Complete the Provisional Trainer certification application for <i>Critical Competencies</i>.</b> Submit the application on <a href="#">ZERO TO THREE   Learn</a> .

<ul style="list-style-type: none"> <li>✓ Be a current approved early childhood trainer in your home state or country <b>OR</b> meet specified standards as an adult educator</li> </ul>	<p><b>Applicants provide at least 1 of the following evidence options as part of the trainer certification application process</b></p> <p><b>Early Childhood trainer:</b> A copy of an official certificate, designation letter, or other written designation of approved early childhood trainer or adult educator status awarded by your state or country professional development system, higher education institution, or other appropriate governance entity</p> <p><b>–OR–</b></p> <p><b>Adult educator:</b> A current resume noting the following evidence:</p> <ul style="list-style-type: none"> <li>• A minimum of a bachelor’s degree in early childhood or a related field; <b>AND</b></li> <li>• At least three years of experience as an adult educator; <b>AND</b></li> <li>• Active participation in professional activities through at least 1 of the following options:               <ul style="list-style-type: none"> <li>○ Membership in an early childhood focused professional organization like ZERO TO THREE, or</li> <li>○ Participation in a community, state, or national initiative related to early childhood, or</li> <li>○ Evidence of ongoing professional development (e.g., an organized professional learning community), or</li> <li>○ Participation in at least 1 state, regional, or national early childhood development related conference</li> </ul> </li> </ul>

Stage 2. CERTIFIED TRAINER		Timeframe: valid for 1 year; candidates document and maintain certification annually
<p><b>Step 1: Confirm you are a current Provisional or Certified Trainer: <i>Critical Competencies</i> on <a href="#">ZERO TO THREE   Learn</a>.</b></p>		
<p><b>Step 2: Complete the ZERO TO THREE Trainer Certification renewal process.</b> Submit the renewal application and pay \$99.00 USD application and processing fee on <a href="#">ZERO TO THREE   Learn</a>. <i>Annual fee includes ZERO TO THREE digital Membership for 1 year.</i></p>

<p>✓ Be a current approved early childhood trainer in your home state or country <b>OR</b> meet specified standards as an adult educator</p>	<p><b>Applicants update or provide additional evidence of at least 1 of the following options as part of the trainer renewal process:</b></p> <ul style="list-style-type: none"> <li>• Current approved trainer status in your home state or country</li> </ul> <p><b>–OR–</b></p> <ul style="list-style-type: none"> <li>• That they meet specified standards as an adult educator (see examples of evidence on page 1)</li> </ul>	
<p>✓ Successfully deliver all modules in at least 1 of the 3 <i>Critical Competencies</i> areas since last certification award date</p>	<p><b>Please Note: All evidence</b> for meeting this criterion <b>must</b> contain the name of training, date(s) of delivery, location, and trainer name.</p> <p><b>Applicants upload the following evidence as part of the trainer renewal process:</b></p> <ul style="list-style-type: none"> <li>• Approved training event record(s) <b>OR</b> training agenda(s); <b>AND</b></li> <li>• A personal reflection on and with at least 1 of the following evidence options:                             <ul style="list-style-type: none"> <li>○ A summary of your training participants’ evaluations</li> <li>○ A letter of recommendation from a peer or mentor trainer, or other formal observer of your <i>Critical Competencies</i> training delivery; letter must be dated within the last year and include the observer’s contact information</li> <li>○ Brief video clip of a <i>Critical Competencies</i> training delivered since last certification award date with a written or video summary</li> <li>○ Other trainer requested documentation options pre-approved by ZERO TO THREE</li> </ul> </li> </ul>	
<p>✓ Participate in at least 1 ZERO TO THREE <i>Critical Competencies</i> trainer support offering since last certification award date</p>	<p><b>ZERO TO THREE will verify this evidence for applicants; DO NOT submit documentation for this criterion</b></p> <ul style="list-style-type: none"> <li>• Verified attendance in a ZERO TO THREE trainer support offering since last certification award date</li> </ul>	
<p>✓ Participate in at least 5 clock hours of professional development in the areas of social-emotional, cognitive, or language and literacy development for infants and toddlers; teaching infants and toddlers; or other areas specifically related to the <i>Critical Competencies</i> model since last certification award date</p>	<p><b>Applicants upload training certificates or transcripts as part of the trainer renewal process:</b></p> <ul style="list-style-type: none"> <li>• At least 5 clock hours of professional development in ZERO TO THREE approved areas since last certification award date                             <ul style="list-style-type: none"> <li>○ Total clock hours may include ZERO TO THREE trainer support offerings or membership events</li> </ul> </li> </ul>
