

# ZERO TO THREE Certified Trainer: DC:0-5™ Certification Criteria and Application Overview



There are two stages of ZERO TO THREE Trainer Certifications: Stage 1. Provisional Trainer; and Stage 2. Certified Trainer. ZERO TO THREE digital Membership is included in both stages of certification. This overview summarizes the ZERO TO THREE Certified Trainer: DC:0-5™ timeframe, criteria, and evidence options by certification stage. This page outlines the first steps of Provisional Trainer application; page 2 outlines the final part of Provisional Trainer Certification followed by Certified Trainer information. Stage 1. PROVISIONAL TRAINER		Timeframe: valid for 1 year; candidates document meeting full Certification criteria within this provisional year
Step 1: You must have an active ZERO TO THREE profile. Create or confirm your learner profile on <a href="#">ZERO TO THREE   Learn</a> .		
Step 2: Complete the 2-part (Parts A and B) Provisional Trainer certification application for DC:0-5™. Submit both parts of the application on <a href="#">ZERO TO THREE   Learn</a> .		
Step 2, Part A: You must demonstrate you meet the following prequalifications and be approved by ZERO TO THREE to attend a DC:0-5™ Training-of-Trainers (ToT)

Step 1: Confirm you are a current Provisional or Certified Trainer: DC:0-5™ on <a href="#">ZERO TO THREE   Learn</a> .		
Step 2: Complete the ZERO TO THREE Trainer Certification renewal process. Submit the renewal application and pay \$99.00 USD application and processing fee on <a href="#">ZERO TO THREE   Learn</a> . Annual fee includes ZERO TO THREE digital Membership for 1 year.
